III. To help, aid, assist, undertake, establish and maintain school including public school for boys or girls or for both and colleges for imparting, general, vocational industrial, physical, mental moral, education to deserving youth of the society without any discrimination whatsoever for advancement of their education, culture, language and art.

IV. To establishment, run and maintain rest house, poor houses and any other such

charitable institutions for the benefit of poor people of Bihar.

To maintain, contribute or to give aid to any existing medical, technical, professional, professional educational or social institutions or any charitable institutions with philanthropic purposes which may be in the general interest of the poor of all castes of community and do all such acts and things with the objects of giving relief to the poor and backward people in general.

X. To maintain, aid and assist the institution or institutions carrying out activities for national integration and preservation and strengthening of secular character

of the Nation.

XI. To do all such acts and things as may be conducive to the well being of the society in general and upliftment of educational and cultural conditions in particular.

XII. To accept donations (in cash or kind) subscriptions, grants, presents and to collect dividends, rents, interest, and other income of the trust fund etc. for

being utilized to further the object thereof.

XIII. To undertake project, programmes and schemes for providing free formal and non-formal education to the poor and illiterate children belonging to urban slum areas, backward rural and tribal areas who for social or economic reasons are not attending schools.

XIV. To undertake projects/schemes for providing minimum basis literacy skill to the illiterates through setting up adult education and non-formal education centres in urban slum, backward rural and tribal areas.

XV. To take up schemes and projects for pollution control, health awareness and birth control family planning programmers.

XVI. To take over with all its assets and liabilities or without previous liabilities and existing educational institution including professional and technical colleges and to own maintain and manage the same already lawfully established by any charitable transfor registered ociety having similar aim and objects if such

Section Summer A Sedhomesingh A sponsoring body or the founder "Trust or society" is unable to run and manage the said existing institution, due to paucity of fund at their disposal or due to their other incapability if they request and offer to take over the said existing academic institution through unanimous resolution of their board of trustees or general body of the society as the case may be.

4. Management of the Trust:

The general management of the trust for the purpose of managing the affairs and properties and carrying out the object of the trust aforesaid shall be vested in the board of trustees. The board of trustees shall consist of chairman and Secretary. The chairman of the trust also will be the chief executive of the trust. The first chairman of the board of trustees shall be Mr. Rajiv Kumar who will hold office of the chairman and the chief executive officer of the trust till his life time. The first chairman of the trust Mr. Rajeev Kumar may nominate his successors in office and trustee-cum-next chairman of the trust. The next chairman of the trust so nominated shall enter into the office of the trustee and chairman of the trust only after the life time of the first chairman. If the first chairman fails to nominate his successor in office in that event after the life time of the first chairman, the trustees shall nominate one trustee to fill up the vacancy and shall also elect the next chairman of the trust for amongst themselves. The first Secretary of the trust shall be Dr. Sanjeev Kumar who will hold office of the trust till his life time. In case of vacancy the chairman of the trust will nominate next secretary of the trust. The secretary shall be custodian of all the records and proceeding books of the meeting of the board of trustees and he shall be responsible for the administration and general management of the affairs of the trust subject to approval of the board of trustees and he shall also be responsible for implementing the decisions/resolutions of the board of trustees. The secretary of the board of trustees shall prepare agenda, fix date, time and venue of the meeting. The chairman shall preside over the meetings of the board of trustee and shall sign the proceeding of every meeting of the board of trustees and without prejudice to the generality of the objects and powers above mentioned, the board of trustees shall have to do all or any of the following that is to say:

 To enter into contracts and borrow money from bank, institutions or individuals for the purpose of the trust and management of its properties and assets.

ii) To appoint consultants for specific purposes on such terms and conditions as they may deem its.

iii) To enter into agreement with organizations and individual for execution of any projects, that may be undertaken or taken over by the trust from time to time.

iv) To make rules and regulation from time to time for the managements and conduct of the affairs of the trust and its properties and assets.

The number of trustees shall seven. The trustees shall be trustees for their life time but, any trustee may resign by giving notice in writing to his co-trustees and shall also cease to be a trustee if requested in writing by three fourth of the remaining trustees or the number nearest thereto. The trustees will also have the following powers:

To apply the whole or part of the income or accumulation thereof or whole or part of the corpus of the trust properties for one or more of the objectives of the trust properties for one or more of the objectives of the trust as the trustees may from time to time determine.

- viii) To appoint, constituted attorney or agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents from time to time and remove such attorneys or agents and to appoint other or others in their place.
- ix) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the trust and for the management of the affairs thereof and of running any institution in furtherance of the objects of the trust and otherwise for giving effect to the objects of the trust.
- x) To set part the whole or part of the income or the corpus or part thereof or any of the objects of the trust.
- xi) It shall be lawful of the trustees to settle and determine all matter of interpretations of these presents as well as all matter of difficulty, of doubt or dispute and all questions arising in the course of or incidental to and the administration, management and execution of the trust and power these presents and any such settlement of determination although the question involved may not have been actually raised shall be valid, binding and conclusive and shall be rejected to or re-opened upon any ground whatsoever.
- To settle, comprise or compound, out of court, all suits actions and other proceedings and to settle all differences and demands and to refer any or all such suits, actions or other proceedings, differences or demands to arbitration and to adjust and settle all accounts relating to the trust fund and execute release and to all things relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasion thereby.
- xiii) That trustee shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper. Persons or agents and to appoint committees as they may think necessary to function under the authority and control of the trustees for carrying out the trust of these presents or the management thereof any may within the limits of their own powers invest them with all such powers including power to incur all such expenditures as may be necessary for carrying out the objects of the trust.

xv) To pay all costs, charges, and expenses incidental to the managements, administration and execution of the trusts and powers herein contained.

xvi) To purchase or hire or to take on lease lands, buildings and other immovable and movable properties in the name of the trust.

xvii) To raise or borrow moneys required for the purpose of the trust on mortgage or pledge of the trust estate or any part thereof with or without any security and such rate of interest and on such terms as the trustees shall think fit.

xviii) To do such act and things which may be incidental and necessary to attain the objectives of the trust?

6. Duties of the trustees:

The trustees shall be chargeable only for such moneys, stocks, share and funds that shall actually come into their hands and shall not be answerable or accountable for neglect, default acts of omission or commission the other trustees nor of any bankers or other persons with who the trust properties of any securities may have been deposited or handed over unless caused by their willful neglect or default.

The trustees shall be bound to deal with the trust property as carefully as a man of ordinary prudence to deal with such property if it were their own. And in the absence of a contract to the contrary, a trustee so dealing shall not be responsible for the loss destruction or deterioration of the trust property.

If the trustee shall commit or threatens to commit any act which shall be destructive of permanently injurious to the trust property, the remaining trustees shall be bound to take measures to prevent such act.

v) The trust shall be bound to keep clean and accurate accounts of the trust property at all reasonable times.

7. Rights of the Trustees:

i)

The trustees will not be entitled to receive any remuneration as trustees but may reimburse themselves of all expenses actually incurred by them in connection with trust or their duties relating thereto. The trustees may from time to time associate with the activities of trust any person or persons of public eminence as patron or patron-in-chief and may appoint or make provision for appointment of committee or managing committees for conduct of the affairs of the trust for the purpose of administration of any projects or scheme/s technical, professional academic institution established or undertaken by the trust in consonance with the object of the trust. The said managing committee may consist wholly of the trustees or partly of trustees and partly of other as the trustees may decide. The chairman of the trust shall be the

The chairman of the trusts Mr. Rajiv Kumar will be the ex-office chairman of the managing committee of all the academic institutions whether general, technical or professional established and administered by the trust and the executive power to administer such academic institutions and to manage the day to day affairs of such institutions shall be vested in the chairman of the managing committee and he shall be the chief executive officer of the such managing committee.

b) Advisory committee appointed by board of trustees shall function under the direct control of the trust and the chairman of the board of trustees shall act as ex-office chairman of the

said advisory committee.

The receipt of a person authorised by the trustees or a resolution of the board of trustees for any money paid or any property transferred or delivered to the trustees in execution of any of the trusts or powers thereof or for the purchase of any property authorised to be sold shall effectually discharge any person or persons so paying to transferring or delivering.

8. Indemnity to Trustees etc.:

The trustees for the time being of the presents shall be chargeable for only such moneys stocks, funds deposits and securities as they shall actually received not withstanding their signing of any receipt neglects, defaults and not for those of each other or any banker, suctioneer or any other person with whom or into whose hands any trust moneys or securities may be deposited or come in accordance with these present nor for the deterioration or loss of any stock, funds, deposits or securities nor for any other losses the same shall happen through their own willful default.

All activities financed from the fund shall be conducted in accordance with the ideas and objects as stated herein and no discrimination shall be permitted therein on grounds of religion, caste, creed or sex, provided that any donations earmarked and accepted for any specific purposes falling within the objects mentioned in THESE PRESENTS shall

be for such specific purpose.

11. ACCOUNTS AND AUDIT:

The books of accounts of the trust shall be closed on 31st March, each year and after the closing, the statement of accounts in such form as the Board of Trustees may decide or determine will be prepared and thereafter the same shall be presented to the Auditors for report, as the Board of Trustees may appoint from year to year, and their remuneration will be decided accordingly in meeting.

12. MEETING:
